## Working with Vulnerable People and Working with Children | Resources Kit

### **The Working with Vulnerable People and Working with Children Resources Kit provides documents and links to support you with your Regional Arts Fund application.**

The *Working with Vulnerable People Act* exists in a number of states and territories around Australia and aims to reduce the risk of harm or neglect to vulnerable people.

The *Working with Children Act* is a key piece of legislation in a number of states and territories that governs how we protect and promote the safety and wellbeing of children and young people.

From 1 July 2019, Regional Arts Australia and the Commonwealth Government require that all personnel performing work (voluntary or paid) in relation to any RAF funded activity that involves children, people with disability or other vulnerable people hold the necessary police and other background checks as required by the relevant legislation in the State/ Territory where the activity takes place.

RAF application forms will ask for proof of checks relevant to the legislation. Each State and Territory has its own legislation. Applicants will need to check the legislation for the State/Territory in which the project takes place.
